1. Preparation and installation

Important! From version 8.0 onwards, Safexpert has improvements which offer easier methods for storing data, for assigning access rights to projects and for updating hazards lists. In order to use the new functions to their fullest extent, it is important that the Safexpert system administrator carries out the appropriate upgrades and data additions after the update to 8.5. This checklist will support you step by step in planning and executing the update. Please adhere to these specifications exactly.

1.5	Carry out a data backup	Back up the existing Safexpert database. Keep this data backup even after the update to Safexpert 8.5.	
1.6	Optional: Export data	See chapter 5 .	
1.7	Install Safexpert	See Safexpert user guide, section 5.	
1.8	Carry out client installation on all PCs	See Safexpert user guide, section 5.4.	

Note: From version 8.0 onwards, Safexpert has a new database at its disposal. During the update, the data from the earlier database is copied into the new database. All data from the previous version remains unchanged. Should the update not run correctly for any reason, you may continue to work with the previous version without any restrictions. It is also possible to operate earlier versions in parallel with Safexpert 8.x. However, it is not advisable to do so, since this may lead to different people working on different databases. Retroactive reconciliation of the data is no longer possible after the update.

2. Update run

Note: Carry out this update run immediately after the update. As a result, all newly available data from the Safexpert Live Server will be automatically transferred to your system.

3. Manual data additions

Safexpert cannot automatically update or add certain data. Therefore, carry out these data additions manually:

Step	To do	Note	Completed
3.1	Add user data	<ul style="list-style-type: none"> In the main menu System, click on the function User management. (see Safexpert user guide, section 16.1). For all users, add the data “department”, “function” and “company location”. Adapt the roles and rights when necessary. 	
3.2	Adapt your own hazards lists (in so far as your own lists are present)	<ul style="list-style-type: none"> In the main menu System, click on the function Hazards lists (see Safexpert user guide, section 16.3) Correct or add the bibliographical data for all your own hazards lists according to the lists mentioned below. 	
3.3	Create a conversion table for your own hazards lists	<ul style="list-style-type: none"> See Safexpert user guide, section 16.3. <p>Note: Please also see section 16.3. Accordingly, it is recommended that you create a conversion of your own hazards lists to the hazards list currently included in Safexpert according to EN ISO 12100:2010 and also add your own cross-reference lists. This will make future updates of your projects easier.</p>	
3.4	Adapting your own checklists	<ul style="list-style-type: none"> In the main menu System, click on the function Checklists (see Safexpert user guide, section 16.3) Correct or add the references for all your own checklists according to the list mentioned below. 	
3.5	Adapting the pictograms libraries	<ul style="list-style-type: none"> In the main menu System, click on the function Pictograms library (see Safexpert user guide, section 16.2). During the update process the existing pictograms libraries were converted to the three languages German, English and French (see note in the column “Title”). <ul style="list-style-type: none"> If you did not add any pictograms in one of these tree converted libraries, delete the converted libraries. If you have added pictograms in one of the converted libraries: delete in all converted libraries all pictograms except the ones that were added by yourself. Correct or add the references for all your own converted pictograms libraries. 	

Note: If you do not carry out this data addition, the Safexpert updating mechanisms may not be able to be used to their full extent.

Adapting or adding bibliographic data for your own hazards lists

The management of hazards lists is carried out in Safexpert 8.0 in the same way as the management of standards. For this reason, a few new data fields have been introduced, but a few have also been removed. Please therefore make these adjustments manually for all of your own hazards lists:

Up to Safexpert 7.1	From Safexpert 8.0 onwards	Note
Identification number	Document number	This is automatically transferred and cannot be changed, because the identification in projects is made on the basis of this number.
Hazards lists	Title	This is automatically transferred.
Description	Brief information	This is automatically transferred.
<i>New in Safexpert 8.0</i>	Language	This is automatically transferred. A hazards list is automatically created in Safexpert 8.0 for every language of a hazards list that existed before the update. Check as and when necessary that all lists are complete and make sure they match the language of the country.
<i>New in Safexpert 8.0</i>	Keywords	Optional: Enter keywords. These will act as aids in locating the lists.
<i>New in Safexpert 8.0</i>	Certified by	Optional: Add the data where necessary
Created by	Created by	This is automatically transferred.
Created on	Created on	This is automatically transferred.
<i>New in Safexpert 8.0</i>	Last change by	This will automatically be transferred from "Created by."
<i>New in Safexpert 8.0</i>	Last change on	This will automatically be transferred from "Created on."
<i>New in Safexpert 8.0</i>	Applicable	This is automatically transferred.
Released	Valid	This is automatically transferred. Check if the details match.
<i>New in Safexpert 8.0</i>	Valid from	Important: Enter the time from when on the hazards lists were applicable.
<i>New in Safexpert 8.0</i>	Withdrawn	Important: Enter the time until when the hazards lists were applicable.
<i>New in Safexpert 8.0</i>	Subject area (ICS)	Optional: Acts as an aid to locate the list. See Safexpert user guide, section 14.3.
<i>New in Safexpert 8.0</i>	Publisher	Optional. This provides information about the creator of the hazards lists.
<i>New in Safexpert 8.0</i>	Based on	Important: Where necessary, enter the standard on which the hazards list is based.
<i>New in Safexpert 8.0</i>	Predecessor document	Important: This enables tracking the history of a hazards list.
<i>New in Safexpert 8.0</i>	Successor document	Important: This enables to track the history of a hazards list.
<i>New in Safexpert 8.0</i>	Changes allowed by the user	Changes to existing hazards lists are only possible if the option "Changes allowed by the user" is activated. This option is not activated during an update so that the hazards list behaves as it

Note: To compare the data with the earlier version, you can open both versions of Safexpert in parallel.

Adjust or add references for your own checklists

The management of checklists is carried out from Safexpert 8.0 onwards in the same way as the management of standards. Please therefore make these adjustments manually for all your own checklists:

Language identification	Language	This is automatically transferred.
Index / Search concept	Keywords	This is automatically transferred.

<i>New from Safexpert 8.0 onwards</i>	Based on	Important: Where necessary, enter the standard on which the hazards list is based.
<i>New from Safexpert 8.0 onwards</i>	Predecessor document	Important: This enables tracking the history of a hazards list.
<i>New from Safexpert 8.0 onwards</i>	Successor document	Important: This enables tracking the history of a hazards list.
Area of use	<i>No longer available</i>	Redundant in the field "Keywords."

Author / Team of authors	<i>No longer available</i>	Redundant in the "Creator" field.
Last checked for updates on	<i>No longer available</i>	The update check is now carried out via the fields "Valid from" and "Withdrawn".
Change log	<i>No longer available</i>	The change log is established via the fields "Predecessor document" and "Successor document". Therefore transfer the data into these fields. Additional information can, where necessary, be saved in the field "Brief information".

4. Disable the preceding version of Safexpert

The data of the previous version (7.1 or earlier) is copied into the new database by updating to Safexpert 8.5. It is also theoretically possible to operate earlier versions in parallel with Safexpert 8.5. However, it is not advisable to do so, since this may lead to people working on different databases. It is NOT technically possible to synchronise the data retroactively. It is therefore strongly recommended that you block access to the old database in any case:

4.1	Block access to the previously used database	Rename the "SystemDB" directory to "SystemDB-updated_to_85."	
4.2	Inform and train all users where necessary.		

5. Test of Safexpert 8.x while work is still being carried out with 7.1 or an earlier version

It is recommended, particularly in companies in which Safexpert is used by multiple users, to plan and coordinate the change to Safexpert 8.5 accordingly. In addition, the Safexpert system administrator can install a version in advance for test purposes. In this case, projects can also be created. The most important changes in Safexpert 8.5 see Safexpert user guide, chapter 3.

If the projects that were created during the tests are to be made available again after the update, proceed as follows:

1. Install Safexpert 8.x in parallel to Safexpert 7.1 or an earlier version.
2. After you have completed your tests, export all data created in Safexpert 8.x, e.g.: projects, checklists, cross-reference lists, report templates, libraries,...
Note: Use distinct file names during the export so that it is possible to easily reimport the files after the update.
3. Back up the exported data.
4. Uninstall the test installation of Safexpert 8.x.
5. Remove the test database of Safexpert 8.x (e.g. from the SQL Server).
6. Reinstall Safexpert 8.x completely (update) according to the aforementioned checklists.
7. Import all data previously exported.
